NATURE, DURATION AND MODE OF STUDY

The programmes comprise of course work and thesis. Students shall be given all study materials in advance including lecture notes to work on their own and only come for campus lectures once in a while as shall be communicated from time to time. CIM or LUC shall organize examinations twice a year in June and January to assess the candidates. The duration of the programme is one or two calendar years depending on the specialty. Degrees awarded meet European standards and are internationally recognized. For University of Buea mentored programmes, the duration is two academic years and shall follow a calendar of activities to be drawn by the Postgraduate School.

CERTIFICATION

Candidates who successfully complete any of the above Master's programmes shall be certified either by University of Buea (UB) or by Cyprus Institute of Marketing in Nicosia, or Lincoln University College, Malaysia, respectively. With the CIM and LUC programmmes, all examinations are set and marked by CIM or LUC in order to maintain international recognition of the degrees awarded. Regarding UB mentored programmes, the University of Buea vets the examinations to maintain standards.

LANGUAGE OF INSTRUCTION

The language of instruction for all our Master's degree programmes is English. Consequently, we advise non-English speaking candidates to enroll for an English language course to supplement their proficiency in English.

NB: Classes are very flexible and especially on weekends giving advantage to workers and people with busy schedules. Lectures commence in October every year at our Mile 3, Nkwen, Bamenda campus.


